future asbestos neoplasia risk in the general population. The risk to more intimately exposed populations will remain for definition and control. This is question enough, but the problem will be a manageable one and within the scope and resources which could be available.

We further suggest that specific asbestos products and uses in the construction and shipbuilding industries have an important relation to occupational and community dissemination of asbestos; focus of control measures here are strongly indicated.
